Used Cooking Oil Webinar a Success!

RSB recently held a worldwide webinar entitled "Accessing the EU Market for Used Cooking Oil" where more than 50 registrants interacted with RSB's Dr. Melanie Williams and Matthew Rudolf, as well as our co-hosts Patrick Lynch from Greenergy and Neil Mendenhall from SCS. RSB's webinar educated participants about the latest certification requirements to sell UCO into different countries within the EU, offered advice and opinions from an SCS auditor perspective, as well as from a large biofuel producer, Greenergy. The Faces of RSB: Participation in Recent Events

- Sébastien Haye attended the 11th Policies Against Hunger Conference, organized by the German Government on 30 June and 1 July. This conference is part of the round of discussions organized under the auspices of the Committee on Food Security, which should culminate with the adoption of the Responsible Agricultural Investments (RAI) principles. Sébastien gave a presentation to emphasize the great overlap that exists between RAI principles and the RSB Standard, which could make credible certification schemes like RSB one of the implementation vehicle of the RAI principles.



- RSB's Matthew Rudolf spoke at the DOE's Bioenergy Technologies Office at Argonne National Laboratory in Chicago on June 24-26. The second edition of the Sustainable Bioenergy Landscapes Workshop convened a discussion on the usefulness and feasibility of using landscape principles to design sustainable bioenergy/row crop systems in the U.S. midwestern agricultural landscape.

- RSB's Board Vice-Chair, Khoo Hock Aun, recently spoke on the sustainability panel at the World Bio Markets Asia conference on 17-18 June 2014 in Kuala Lumpur, Malaysia. World Bio Markets Asia is the first Asia-based international event looking at upstream development and conversion technologies in the Asian bio-based markets both in the bio-based fuels and chemicals markets.



- On June 16, Rolf Hogan presented RSB as a model certification scheme for sourcing sustainable biomass to European businesses attending the Leaders for Nature (www.leadersfornature.nl) Masterclass organized by IUCN Netherlands in Rotterdam Zoo. Participants included AkzoNobel, Eneco, DSM, IBM, KPMG, Philips and Unilever.

- Rolf Hogan, RSB's Executive Secretary, spoke at the Fuels for Future panel along with Volvo, UPS and the city of Toulouse at the BSR (Business for Social Responsibility) Spring Forum in Paris, France on June 12. RSB has been collaborating with BSR on its "Future of Fuels" initiative in the US for several years.

- RSB's Melanie Williams was part of a panel discussion on Biofuels Voluntary Sustainability Schemes at the Oleofuels 2014 conference in Dusseldorf, Germany on June 11-12. Oleofuels 2014 is the progression of ACI's European Biodiesel series of events which ran from 2008-2013. The change of name reflects the fact that the event will now cover all fuels made from oils and fats including biodiesel, HVO and bio jet as well as take a more global view.



- Barbara Bramble represented RSB on the SE4ALL Sustainable Bioenergy High Impact Opportunity Steering Committee at the UN in New York on June 4.

Standard Update

Several standards and procedures were recently approved by the Assembly of Delegates (28 May) or Board of Directors (2 July). These are:

- [Global](#) and [EU RED](#) version of the RSB Standard on Risk Management - Version 3.0 This Standard was revised to improve clarity and user-friendliness, in particular the calculation of operators' risk class.
- [Global](#) and [EU RED](#) version of the Procedure on Communication and Claims. This procedure describes allowed on-product and off-product claims for RSB certified operators; Version 3.0 introduces a new "EU RED Compliant" on-product claims for RSB certified operators using raw material certified by another EU-recognised scheme.
- [EU RED version](#) of the RSB Standard for Participating Operators. This standard describes each step RSB Participating Operators shall follow throughout the certification process. Version 3.0 provides a more streamlined and user-friendly approach.
- [Phase-in Procedure](#). This new procedure allows Participating Operators to take up to one year to implement a new or revised standard or procedure.

The ongoing public consultation on the RSB Standard for small-scale producers is ending soon! Please send us your comments by July 16. More information can be found at the [RSB Public Consultations web page](#).

Upcoming consultations (Summer-Fall 2014) will address Chain of Custody procedures and the finalization of the

Standard for smallholders.

Smallholder Update

RSB's Smallholder Project is moving forward, having selected 2 pilot projects in South Africa and 2 more in Brazil. These smallholder groups will be guided through the steps to certification and connected to markets for selling their feedstocks.

RSB will hold RSB Southern Africa Day in Johannesburg (4 August) in tandem with RSB Auditor Training by AB Training (5-7 August) - details are below in upcoming events section.

The Smallholder Project has also been selected as a "High Impact Initiative" of the bioenergy section of the United Nations Sustainable Energy for All (SE4All) initiative. RSB has joined the steering committee for SE4All's bioenergy section on High Impact Opportunities and Chair Barbara Bramble participated in the first meeting in June.

RSB Only Initiative Demonstrating 100% Coverage of All SSI Greenhouse Gas Indicators

The latest "State of Sustainability Initiatives Review 2014: Standards and the Green Economy" report indicates that the RSB is the only initiative demonstrating 100 per cent coverage of all three SSI greenhouse gas indicators. The State of Sustainability Initiatives (SSI) project is facilitated by the Sustainable Commodity Initiative and has been directly managed by the International Institute for Environment and Development (IIED), the International Institute for Sustainable Development (IISD), the Finance Alliance for Sustainable Trade, Environment and Trade in a World of Interdependence (ENTWINED), and the Sustainable Trade Initiative (IDH).
